UVTV MUSIC VIDEO/LIVE PERFORMANCE BROADCAST AGREEMENT

Thanks for submitting the below noted music video or live performance for consideration for broadcast on the television show & website Underground Video Television (UVTV). This letter of agreement will confirm the terms and conditions for the broadcast rights that you hereby grant to UVTV Productions, LLC, which produces the television show "Underground Video Television" and operates the website www.uvtv.info.

1. You hereby grant Underground Video Television (hereby referred to as UVTV) in perpetuity, the irrevocable right and license to record, broadcast and exploit the music video or live performance identified below (the "Video") on UVTV throughout the world (including but not limited to all future shows, television stations and networks operated by UVTV Productions). Such broadcast rights include without limitation broadcast by terrestrial television, satellite, cable, pay, DBS and SMATV means as well as every other form of television transmission or broadcast available now or in the future. Broadcast rights also include internet streaming and download on any website operated or owned by UVTV Productions. You warrant and agree that UVTV will not be required to make any payment to you or any other third party in the exercise of the rights granted herein and you hereby acknowledge that you shall receive valuable consideration in the form of promotion of the musical artists featured in the video.
2. You represent that you have the full right and authority to grant to UVTV full and unrestricted broadcast rights and internet use as described in paragraph 1 to the Video and that our exercise of such rights shall not constitute an infringement of any copyright, civil, personal or property right of any third party. You further warrant that you have secured all consents, licenses, clearances of every kind necessary to permit free and unencumbered broadcast of the Video on UVTV.
3. It is understood and agreed that UVTV shall have no obligation to broadcast your Video and that the decision with respect to the same shall be determined in our sole discretion. All submission materials become the property of UVTV and will not be returned.
4. You hereby agree to indemnify UVTV, its officers, employees and agents, from and against any and all claims, demands, actions, losses, liabilities, costs and expenses arising from your breach or alleged breach of any term, warranty or condition of this agreement. You agree to reimburse UVTV on demand for any payment made or incurred by UVTV provided the claim concerned has been settled or has resulted in an enforceable judgment. UVTV shall have the right in its absolute discretion to settle, compromise or satisfy any judgment that may be rendered, or resolve or dispose of any other manner, any claim, matter, action or proceeding.
